This British Standard is the UK implementation of EN 60335-2-7:2003+A11:2010, incorporating corrigendum July 2003. It is derived from IEC 60335-2-7:2002, incorporating amendments 1:2004 and 2:2006. It supersedes BS EN 60335-2-7:2003+A2:2006 which will be withdrawn on 14 April 2013.

The start and finish of text introduced or altered by amendment is indicated in the text by tags. Tags indicating changes to IEC text carry the number of the IEC amendment. For example, text altered by IEC amendment 1 is indicated by **A1** **A1**.

The CENELEC common modifications have been implemented at the appropriate places in the text. The start and finish of each common modification is indicated in the text by tags **C** **C**. Where a common modification has been introduced by amendment, the tags carry the number of the amendment. For example, the common modifications introduced by CENELEC amendment A11 are indicated by **C11** **C11**.

The UK participation in its preparation was entrusted by Technical Committee CPL/61, Safety of household and similar electrical appliances, to Subcommittee CPL/61/14, Home laundry and dishwashers.
