This British Standard is the UK implementation of EN 14081-1:2005+A1:2011. It supersedes BS EN 14081-1:2005, which is withdrawn.

EN 14081-1 is a candidate "harmonized" European Standard and fully takes into account the requirements of the European Commission mandate M 112, "Structural timber products and ancillaries" given under the EU Construction Products Directive (89/106/EEC), and is intended to lead to CE marking. The date of availability of EN 14081-1 as a harmonized European Standard, i.e. the date from which this standard may be used for CE marking purposes, is subject to an announcement in the Official Journal of the European Communities.

The Commission in consultation with Member States have agreed a transition period for the co-existence of harmonized European Standards and their corresponding national standard(s). It is intended that this period will comprise a period, usually nine months after the date of availability of the European Standard, during which any required changes to national regulations are to be made, followed by a further period, usually of twelve months, for the implementation of CE marking. At the end of this co-existence period, the national standard(s) will be withdrawn.

EN 14081-1 is the subject of transitional arrangements agreed under the Commission mandate. In the UK, the corresponding national standards are BS EN 518:1995 and BS EN 519:1995, which will be withdrawn in June 2007.

National Annex NA describes United Kingdom requirements for structural timber.

The UK participation in its preparation was entrusted to Technical Committee B/518, Structural timber.
