National foreword

This British Standard reproduces verbatim IEC 603844:1998 and implements it as the UK national standard. It supersedes BS 9930-03.0:1988 which will be withdrawn on 31-12-98. This standard is a harmonized specification within the IEC system of quality assessment for electronic components (IECQ).

The UK participation in its preparation was entrusted by Technical Committee EPL/40, Capacitors and resistors for electronic equipment, to Subcommittee EPL/40/1, Capacitors and EMI suppression components for electronic equipment, which has the responsibility to:

- aid enquirers to understand the text;
- present to the responsible international/European committee any enquiries on the interpretation, or proposals for change, and keep the UK interests informed;
- monitor related international and European developments and promulgate them in the UK.

A list of organizations represented on this subcommittee can be obtained on request to its secretary.

The standard is to be used in conjunction with BS QC 300000:1983, Harmonized system of quality assessment for electronic components: Fixed capacitors for use in electronic equipment: Generic specification.

The British Standard which implements the IECQ Rules of Procedure is BS 9000-3:1996, General requirements for a system for electronic components of assessed quality — Part 3: Specification for the national implementation of the IECQ system.

From 1 January 1997, all IEC publications have the number 60000 added to the old number. For instance, IEC 27-1 has been renumbered as IEC 60027-1. For a period of time during the change over from one numbering system to the other, publications may contain identifiers from both systems.
