## Foreword

Translator's note: This translation is to be used in conjunction with the English translation of DIN 1045-2, July 2001 edition.

The following amendments supplement or supersede the specifications of DIN 1045-2 (unless otherwise specified in the left-hand column). They are the result of practical experience with the standard since its publication and take into account European Standards for construction products, which have been published recently, and new specifications for type CEM II cement.

The German-language version of DIN 1045-2/A1 incorporates the amendments from a Corrigendum to DIN 1045-2 (DIN 1045-2 Ber 1) issued in June 2002, together with new amendments. **This English translation indicates the new amendments only. The former are already included in the English translation of DIN 1045-2 and are not repeated here.**

In this standard, the same numeration and clause headings are used as in the English translation of DIN 1045-2 and DIN EN 206-1. Any departures from these standards (i.e. additional text, substitutions, deletions) are indicated on the left-hand side of the page, with any new wording given on the right-hand side.
