### National foreword

This British Standard is the official English language version of EN 14225-4:2005.

The UK as a member of CEN, is obliged to publish EN 14225-4:2005 as a British Standard. However, attention is drawn to the fact that during the development of this European Standard, the UK consistently voted against its approval as a European Standard.

The reason for this disapproval was the committee's concern that One Atmosphere Suits (ADS) are submersible craft and are legislated under maritime law and resolutions published by the International Maritime Organisation and, in the committee's opinion, should not be considered Personal Protective Equipment (PPE). The committee would therefore draw the readers' attention to the fact that current Merchant Shipping Acts and Regulations made under them, and International Maritime Organization Resolutions on submersibles should be consulted prior to applying the content of this standard.

The UK participation in its preparation was entrusted by Technical Committee PH/3, Protective clothing, to Subcommittee PH/3/6 and PH/3/6/2 Buoyancy garments — Diving suits, which has the responsibility to:

- aid enquirers to understand the text;
- present to the responsible international/European committee any enquiries on the interpretation, or proposals for change, and keep UK interests informed;
- monitor related international and European developments and promulgate them in the UK.
