Amendments

This standard differs from DIN 79121:1986-11 as follows:

- b) Classification has been introduced.
- Security of safety-related fasteners has been included.
- d) Crack detection methods have been included.
- e) Protrusions have been dealt with.
- f) Provision for lighting has been included.
- g) Strength under high and low temperatures has been included.
- h) Dynamic load test has been included.
- i) Static load test has been included.
